Artificial insemination with fresh/chilled semen (period to be determined) or deep-frozen semen of the studhorse named Chacco Blue II (born on March 27, 2007. Stallion: Germany, Oldenburg, father: Chacco Blue, mother: Naiti Rouge, grandfather on the mother side: Cincaba Rouge, Colour: Bay).

Contracting parties:

1. Contractor

Tallin Farm on behalf of Attila Kórusz, owner (place and time of birth: Veszprém, May 08, 1972, name of mother: Elza Lampert, place of residence: 1075 Budapest, Kazinczy utca 9), as the sole and full owner of the deep-frozen semen of studhorse named Chacco Blue II and the exclusive beneficiary of exercising the distribution right.

Insemination and payment conditions

1. The stallion semen, including also the non-used full and used artificial straws are the property of Contractor during each phase of the insemination process.

After having completed insemination either successfully or unsuccessfully, the Inseminating Vet or the Mare Owner may not claim any additional artificial straws.

All empty straws has to be returned to Tallin Farm - Danish Sports Horses LLC.

2. The first insemination may be carried out exclusively after the payment of the full Insemination Fee.

3. The amount of the Insemination Fee is 2000 USD + tax that is two thousand USD. This amount has to be paid by the Mare Owner directly to Tallin Farm as distributor / Contractor or the Mare Owner has to hand it over to the Inseminating Vet, in case distributor / Contractor authorised the vet to accept payment for the semen. The amount of 2000 USD is subject to collection fee and shipping fee for fresh chilled semen at approximately \$ 550.00 total per collection or subject to round trip shipping fee, tank rental/charge and vet handling for frozen semen at approximately \$500.00 per shipment. Only one breeding dose will be shipped at a time.

4. For the above Insemination Fee exclusively the above described mare may be inseminated, the insemination of a second mare for one insemination fee is strictly prohibited. Only one foal can be produced per Insemination / breeding fee paid. ICSI is allowed but only at a lab approved by Tallin Farm and only 1 embryo can be frozen per stud fee paid. For each additional embryo produced beyond 1 an additional stud fee of \$ 2000.00 is due to Tallin Farm. Tallin Farm will require a report direct from the lab of the result of the ISCI session and will invoice mare owner for additional embryos produced. A frozen straw for ICSI will be send to the approved lab

and clips can be taken from this straw when authorized by Tallin Farm but the remaining straw remains in the ownership of Tallin Farm & the stallion owner.

5. The insemination fee entitles insemination at most on 3 occasions (3 heat cycles). One insemination may be done within each cycle. 3 artificial straws have to be used for each insemination or one dose of fresh/chilled semen.

6. If the mare becomes pregnant, the Mare Owner may have no claim for additional artificial straws or for any refunding, the remaining artificial straws are the property of Contractor. Prior to inseminating each new mare a new total insemination fee has to be paid.

7. If the mare does not become pregnant after three used cycles, the Mare Owner is obliged to notify Distributor / Contractor in writing within 3 days after the last unsuccessful pregnancy test.

8. Distributor / Contractor will refund the amount of 700 USD to the Mare Owner within 15 days after being notified about unsuccessful insemination.

9. If the mare gets pregnant and subsequently the fetus lost (early fetus resorption, abortion or lost within 3 days after birth), the Mare Owner has to send to Contractor a written vet certificate within 5 days about the loss of the embryo or fetus.

10. If the loss of the fetus takes place before day 90 of pregnancy, Broker will refund the amount of 700 USD to the Mare Owner.

11. If the loss of the fetus occurs after day 90 of pregnancy, no money refunding is due. In this case the owner of the mare is entitled in the year that follows insemination to the new insemination of a mare (at most on 3 occasions). If this mare will not become pregnant, or if its fetus is lost, the mare owner may not have any additional claims. This possibility may not be transferred to subsequent years and it may not be transferred to another owner/mare.

12. Within 15 days after the reporting of successful pregnancy, Contractor will issue and send to the Mare Owner the insemination certificate.

13. No other person is entitled to issue an insemination certificate than the Contractor, and if it is issued without authorisation, the issuing person, without the possibility of any further legal dispute is obliged to pay to Contractor USD 20,000 that is twenty thousand USD compensation.

14. If Contractor learns about a fetus or foal that is not reported to him, the Mare Owner is obliged to pay a compensation of 20,000 USD that is twenty thousand USD without any further legal dispute.

15. Contractor declares that during communication between each other he will consider as legally effective the notifications that are sent to the following email addresses:

tallinfarmdsh@gmail.com and info@chaccoblue2.com, and he will also consider messages sent to phone number +1 908 500 9914 (TallinFarm) and +36 30 330 9999 (owner) as effective communication.

16. Mare Owner simultaneously with signing this contract declares and accepts that Attila Kórusz is the exclusive beneficiary of distributing the deep-frozen fertilizing material of studhorse named Chacco Blue II and using the sperm without permit will automatically result in the obligation to pay the compensation that is stipulated in Points 13 and 14 of the contract.
