# BREEDING FEE

The breeding fee is non-refundable. The breeding fee for Chacco-Blue II for the 2026 breeding season is:

USD 2,250 (two thousand two hundred fifty US dollars) per breeding right / per mare. The breeding fee includes access to Chacco-Blue II genetic material, up to three (3) breeding cycles per mare within one breeding season and the opportunity to produce one (1) live foal, subject to the terms and conditions of this Agreement.

# COLLECTION / SHIPPING FEE

Collection and shipping fees are charged separately for each shipment, not included in the breeding fee, payable by the Mare Owner.

For fresh, chilled semen, an additional technical fee of approximately USD 550 per collection applies. This fee includes semen collection, processing and packaging, veterinary documentation, and express shipment (overnight / next-day delivery) depending on destination.

# NUMBER OF ATTEMPTS

The breeding fee entitles the Mare Owner, per mare, to a maximum of three (3) breeding cycles within one breeding season. One breeding cycle equals one semen dose used for one mare, one semen dose may be used for one (1) mare only.

# PREGNANCY AND LIVE FOAL POLICY

If the mare does not become pregnant after three (3) breeding cycles, OR the pregnancy is lost, OR the foal dies within seventy-two (72) hours after birth, then the Mare Owner shall be entitled to one (1) additional breeding opportunity in the following breeding season, without payment of an additional breeding fee, provided that collection and shipping fees remain payable. This entitlement may be transferred to another mare owned by the same Mare Owner, may not be transferred to another owner, may not be sold, assigned, or otherwise transferred.

# DEFINITION OF LIVE FOAL

For the purposes of this Agreement, a “live foal” is defined as a foal that is born alive, and remains alive for a minimum of seventy-two (72) hours after birth.

# CERTIFICATES AND DOCUMENTATION

The Mare Owner shall provide written veterinary documentation confirming pregnancy examinations, pregnancy loss, foal death (if applicable). Failure to provide proper documentation may result in the loss of any future breeding entitlement under this Agreement.

# GOOD FAITH COOPERATION

The parties agree that the purpose of this Agreement is to establish a long-term breeder relationship, to operate a fair and market-driven genetic program, to reasonably reduce breeder risk, without compromising the sustainability, integrity, or genetic value of the Chacco-Blue II breeding program.

# GOVERNING LAW

This contract is governed by United States commercial contract principles, applicable to interstate breeding agreements.
